LIFE IS A HIGHWAY...

Major patch work was done on Chicks Lane, Tower Road, and Scotch Valley Road. We used C.O.G. for three days to pave parts of the above roads. Minor patch work was done on Cedarhead Road, Mt. Laurel Trail, and Hazle Street in Weston.

We have received a permit from DEP to replace the pipe on the corner of Tower Road and Cedarhead Road. The pipe will be replaced in the spring. We also replaced pipes on Seiwell Lane and Mt. Laurel Trail. We replaced three pipes on Cedarhead Road and two pipes on Tower Road. We sealed where the new pipes were installed and also around the garage.

Ditches were cleaned on Chicks Lane, Tower Road, Gross' Corners, and along the roads in Nuremberg, Weston and Rock Glen.

We moved along the state and township roads, and we moved the park and pool area as well as Alumni Park four times.

We worked on the Racoon Creek wall in Weston

We cut brush on the Boulevard Road, Mt. Laurel Trail, Cedarhead Road and Pine Street.

We replaced the sign on Top Street.

We worked on the culvert and the Dump Road to prevent washout and flooding. We cleaned up after the freak snow storm on Chicks Lane, Tower Road, Larocks Lane, and Gross' Corners.

We put the spreaders and plows on all of the trucks, and serviced them for the winter.

As for recycling, we took junk to the junkyard twice, and took 252 tires to the recycling center in Butler Township.

MONEY, MONEY, MONEY, MONEEE...

We completed and received approval for the Community Development grant for 2010. The amount of the grant is \$100,000.00. We will be doing an income survey to those individuals living on the roads that were identified for improvement at the end of November.

Our 2010 budget for Black Creek Township has been completed with the total amount being \$654,159.00. P.I.R.M.A. has completed a review of our pension requirements, and we are in the process of completing that. Township funds ending October 2009 were: General Fund - \$56,178.13 State Fund - \$2,245.84 (**NOTE:** This fund is supposed to be used up by the end of the year.) Money Market Account - \$137,630.40

We have interviewed all of the candidates for the Zoning/Ordinance Enforcement opening in our township. The supervisors will appoint the new officer in the near future.

We have completed the process for the newly created UCC Board and Planning Commission. These individuals will be named in the near future, and will assume their positions in January 2010.

Rhonda Lescowitch will be our delegate for the Luzerne County Tax Collection Committee under Act 32.
