Supervisor Cheesman informed him that we are aware of the issues on Chicks Lane and they will be addressed as time goes on as our finances permit. Mr. LaBuda also asked about the status on the Chicks Lane Bridge. Supervisor Feerrar stated that we were in contact about that bridge with PennDOT and that we moved up on their list to get that bridge repaired. Supervisor Yacowatz added that they will have to source the funding for it first and go from there, and he also stated that for now, we wanted to smooth out the rough parts of that bridge enough and filled the holes and smoothed out the transitions from road to bridge as best we could.**

**Mr. Allan Roeder had a comment about the revised Zoning Ordinances and wanted an update. Supervisor Cheesman informed him that the final meeting on the Zoning Ordinances is tomorrow at noon and after that they will be posted on the website. Supervisor Cheesman also consulted with Solicitor Logsdon about what their firm does with the new ordinance. Solicitor Logsdon informed him that they will be on the website, but when the Supervisors have a vote on it, it will be advertised in the newspaper for a public hearing. There will also be copies here at the township available as well.**
