## January 4, 2021

### Reports:

**Zoning Report:** Zoning/Codes Officer Carl Faust's report: Carl performed several site visits within the township, and is still compiling violations from those site visits. He issued 4 permits, and 1 violation notice last month.

**Fire Company:** Fire Chief Joe Lescowitch still has not provided a report.

**Emergency Management:** Steve Motil attended a webinar on Flood Plain Management, and virtually attended the advanced portion of Flood Plain Management.

**Engineer Report:** Engineer Jason Snyder- his report was reviewed during new business.

**Road Department:** The Roadmaster report was reviewed by Chairwoman Rohrbach.

A discussion ensued, as Supervisor Rohrbach reviewed a problem; residents are plowing their snow across township roads, causing bumps, lumps, and tons of snow, on the roads, after they were already plowed, causing the township to spend more money by having the road crew go out and plow all over again. It's a safety hazard.

She added that the road crew properly winterized the pool, which had not been done last year.

### Old Business:

### New Business:

- The Weston Speed Study was conducted by the township Engineer. He concluded that the speed limit should be 25 mph, instead of 35 mph. He suggested in his study, that to be efficient, we put the new speed limit signs up on all the roads leading into Weston (3 or 4). That way, signs would not have to be added throughout all of Weston. An ordinance for the speed limit will have to be created, as the previous one is outdated. Supervisor Rohrbach will discuss this ordinance further, with the solicitor and it will have to be advertised.

- Planning Commission member, Leon Fountain, has had to resign from the position, as his job has been requiring he work 12 hour days. His term was from February 6, 2020 to January 31, 2021.
- A motion by Supervisor Rohrbach, to appoint Sarah Fountain, to replace Leon Fountain, for the remainder of his term, until January 31, 2021. Seconded by Supervisor Davis.
- All in favor: Davis; aye, Rohrbach; aye.
  
- A motion made by Supervisor Rohrbach, seconded by Supervisor Davis, to cancel the next work session.
- All in favor: Davis; aye, Rohrbach; aye.

**Public Comment:**

Arty Dice of Fall St., in Rock Glen, commented on the Bloomsburg address for 1980 Tomhicken Road.
