**COME AND ENJOY THE FIREWORKS AT DUSK!!!**

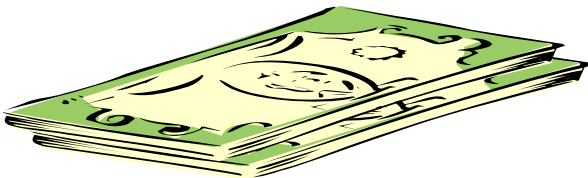
